5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
6. The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
7. The PHA will affirmatively further fair housing by examining their programs or proposed programs, identifying any impediments to fair housing choice within those programs, addressing those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and by maintaining records reflecting these analyses and actions.

  15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
  16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
  17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
  18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
  19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.

### **Progress Made Toward Goals From Prior 5-Year Plan**

During the 2015-2019 5-Year period, the BHA achieved the following milestones:

- Maintained High Performer status for the PHAS certification with a score of 93 in 2015, 94 in 2016, 96 in 2017, 98 in 2018, and 97 in 2019
- Achieved a High Performer status in the voucher program SEMAP certification
- Entered into an agreement to develop 51 units of new affordable family housing in Bourne
- The BHA used funding from Capital Fund grants to repair the parking lot and add additional parking spaces, replace exterior doors on tenant buildings, and replace flooring in the Community Room
- BHA installed new LED lighting and fixtures in tenant units, common areas, and parking lots and new refrigerators to improve energy efficiency and marketability of the property through an energy efficiency grant.
- BHA staff received additional training in rent calculation, safety and security, and management of the HCV program
- BHA updated its Admissions and Continued Occupancy Policy, Section 8 Administrative Policy, Reasonable Accommodation Policy and Violence Against Women Policy
- IT systems were upgraded, housing management software was upgraded, and a website was launched
- Promoted self-sufficiency and asset development by partnering with Elder Services, Bourne Council On Aging, and Cape Organization for the Rights of the Disabled to provide supportive services to seniors to help them maintain their tenancy and independence

### **Goals and Objectives/Strategies For Addressing Housing Needs**

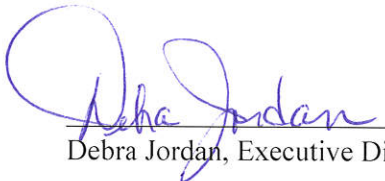
- Expand the supply of assisted housing by:
  - Complete development of 51 units of affordable housing at Cape View Way
  - Reduce public housing vacancies by maintain a vacancy rate of less than 3%
  - Renovate and/ or modernize public housing units, common areas, and grounds
  - Update approximately 56 kitchens to make units more marketable and increase resident satisfaction and ease of use if funding is available
- Improve the quality of assisted housing by:
  - Maintain High Performer designation in the voucher program SEMAP certification and the public housing PHAS certification
  - Utilize capital fund grants to address capital needs and reasonable accommodation requests
  - Research RAD, project-based assistance and other alternative funding programs.
- Promote self-sufficiency by:
  - Provide and attract supportive services to increase independence for the elderly and disabled

- Partner with local agencies, organizations, and the town to provide information, transportation, food options, and social activities for the elderly and disabled
- Ensure equal opportunity and promote fair housing to ensure access to assisted housing regardless of race, color, religion, national origin, sex, familial status and disability
- Other Goals:
  - Update the office area and community room to provide increased security for applicant, tenants, and staff.
  - Reconfigure and update office area to provide increased accessibility, privacy, and efficiency
  - Revise the public housing lease in accordance with all federal regulations and notifications
