

## **BOURNE HOUSING AUTHORITY WEAPONS POLICY**

Bourne Housing Authority (“BHA”) takes very seriously the safety of all tenants and visitors to our property. BHA expects that tenants and visitors will not engage in unlawful behavior while on BHA property. This prohibition extends to unlawfully possessing, carrying, or keeping a weapon on BHA property. “Weapon” as used in this policy includes the items described in Mass. Gen. Laws Ch. 269, § 10 (see attached description of “weapon” attached as part of this policy).

In the interest of safety and in recognition of the rights afforded individuals by the United States Constitution and the Constitution of the state of Massachusetts, BHA will not enter into a lease agreement with a prospective tenant, and will immediately terminate, without grievance hearing, a lease agreement with an existing tenant, who:

1. Unlawfully possesses or carries a weapon of any kind on or adjacent to BHA’s property;  
or
2. Unlawfully possesses or uses an explosive or incendiary device on or adjacent to BHA’s property; or
3. Fails to store or keep a firearm, rifle or shotgun in compliance with Mass. Gen. Laws Ch. 140, § 131L; or
4. Carries or controls a loaded firearm, while under the influence of intoxicating liquor or marijuana, narcotic drugs, depressants or stimulant substances, or vapors of glue; or
5. Engages in any criminal activity that threatens the health, safety, or right to peaceful enjoyment of the premises by other residents, property management staff, and individuals residing in the immediate vicinity of BHA.

For the purpose of this policy, “BHA property” includes: all BHA owned buildings and grounds, including parking areas.

The following acknowledgments must be made by all prospective and current adult occupants of a BHA unit:

- A. I, \_\_\_\_\_, understand, acknowledge, and agree that BHA will not enter into a lease and will immediately terminate a lease agreement for:
  - federally funded housing, and/or
  - state funded housing;for failure to comply with any of items listed above.
- B. I understand, acknowledge, and agree that BHA will place copies of unexpired permits for all weapons in my BHA file. \_\_\_\_\_ (*initial*)
- C. I understand, acknowledge, and agree that BHA will provide a list of units that house weapons to the local police and fire departments. \_\_\_\_\_ (*initial*)

- D. I understand, acknowledge, and agree to notify BHA of any changes of adult occupancy and that such changes may impact not only this policy but other policies and legal documents. \_\_\_\_\_ (initial)

Failure of a prospective tenant to sign this acknowledgment will result in the denial of a lease application. Failure of a current tenant to abide by all terms and conditions of the policy will result in termination of the lease.
